

## Gift Giveaway RULES AND REGULATIONS

## **OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED.

OPEN ONLY TO LEGAL RESIDENTS OF MARYLAND, VIRGINIA AND WASHINGTON, DC

18 YEARS OF AGE OR OLDER.

- 1. PARTICIPATION: By completing the entry form to enter the Gift Giveaway promotion (the "Promotion") and providing your valid contact information for the Promotion you are officially entered into this Promotion and you agree to be bound by the following rules (the "Official Rules"), which constitute a binding agreement between you, on one hand, and Starpower Communications, LLC, a Delaware limited liability company doing business as Astound Broadband powered by RCN on the other hand (the "Sponsor").
