



Astound Casting Call

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER, APPLY FOR, OR BE SELECTED FOR THIS CASTING CALL. OPEN TO ALL LEGAL RESIDENTS OF THE U.S. 18 YEARS OF AGE OR OLDER.

THIS CASTING CALL IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH META ("META", "FACEBOOK", and/or "INSTAGRAM") OR X Corp. ("X") OR GOOGLE LLC ("GOOGLE" and/or "YOUTUBE") OR ANY OF THEIR AFFILIATES. INTERNET ACCESS IS REQUIRED FOR APPLICATION.

1. **PARTICIPATION:** By completing the application form and providing your valid contact information to the Astound Casting Call (the "CASTING CALL"), you are officially applied into the CASTING CALL and you agree to be bound by the following rules ("Official Rules"), which constitute a binding agreement between you, on one hand, and RADIATE HOLDCO, LLC doing business as ASTOUND BROADBAND ("SPONSOR"), on the other. These Official Rules apply only to the CASTING CALL (as defined above) and not to any other campaigns conducted by SPONSOR.
2. **ELIGIBILITY:** The CASTING CALL is open to all legal residents of the United States who are 18 YEARS OF AGE OR OLDER as of date referenced below as the start date for the CASTING CALL ("Entrants"). Proof of residency and age may be required. SPONSOR's employees and their immediate families (spouses, parents, children, siblings, and their respective spouses), including household members of SPONSOR's employees (regardless of whether related to a SPONSOR employee), are not eligible to enter or win. 3. **HOW TO ENTER:** All CASTING CALL applications must be made by completing the application form accessible via astound.com/casting-call. All Entrants are required to provide valid, up-to-date contact information between March 5, 2025 at 9:00AM EST and April 13, 2025 at 6:00PM EST.

EACH QUALIFIED SUBMISSION MUST:

- o Be received within the designated timeframe listed below
AND CONTAIN:
- o Legal first and last name
- o Current mailing address (P.O. Boxes are not permitted)
- o Current, valid phone number
- o Current, valid email address
- o Audition video (30-seconds in length), showing how you/you and your family use Astound's services to make your life better.

SUBMISSION WILL BE DISQUALIFIED IF:

- Submission includes unsafe/profane language or messaging,
- Submission does not abide by the channel community policies
- Submission features other brand logos

SPONSOR will accept applications to the CASTING CALL starting on March 5, 2025 at 9:00AM EST and ending on April 13, 2025 at 6:00PM EST.

By entering the CASTING CALL, all qualified submissions become eligible to be cast. Out of all qualified submissions, five (5) will be selected any time during the submission period.

All cast members will be selected based on, in SPONSOR's sole discretion, among qualified submissions. All cast members will be contacted by SPONSOR by phone and/or email within three (3) business days after the cast members have been selected.

All applications submitted as part of the CASTING CALL shall become the property of SPONSOR. The submission shall constitute an assignment of the copyright and all other rights to the application. SPONSOR assumes no responsibility for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability, or garbled or jumbled transmissions, or service provider/Internet/website/use net accessibility or availability, traffic congestion, or unauthorized human intervention. SPONSOR reserves the right to modify, suspend, or terminate the promotion in whole or in part by giving such notice, in any form and manner deemed appropriate by SPONSOR. Should promotion be modified, suspended, or terminated as aforesaid, the prizes will nevertheless be awarded from eligible applications previously received and in accordance with these Official Rules.

4. **CONDITIONS OF APPLICATION:** A qualified application must be received via astound.com/casting-call. Incomplete applications may be declared void. RESTRICTIONS:

- o One application per household will be eligible to participate in the CASTING CALL. Duplicate applications will be disqualified.
5. **COMPENSATION:** By entering the CONTEST, all qualified submissions become eligible to win compensation. Out of all qualified submissions, FIVE (5) Winners will be selected any time during the submission period. The compensation is as follows:

The courtesy services have no cash redemption value. Any federal and state taxes on the prize are the sole responsibility of the cast members. Only one application per household will be eligible to participate in the CASTING CALL.

By applying to and/or entering the Casting Call you agree to receive email communications periodically from SPONSOR. You can opt-out of receiving this communication at any time by clicking the unsubscribe link in the email communication.

7. **COLLECTION OF INFORMATION:** SPONSOR will not sell, rent or otherwise transfer any information, obtained throughout the course of this CASTING CALL, to any third party. As stated above, the CASTING CALL is not open to minors under the age of majority in their country of residence without the express consent of a parent or legal guardian. In the event that you are under the age of eighteen (18) and submit applications to SPONSOR, SPONSOR will delete, erase or destroy any and all personally identifiable information that is obtained from the applications following the conclusion of the CASTING CALL.
